- Entry forms which do not include a full list of ingredients will be ineligible for the competition

The winning products will be judged on the morning of Saturday 18 September at the WI tea tent at the Somerset County Show event. The decision of the judges is final. Exhibits will be on display until 12 noon on Saturday 18<sup>th</sup> September and will be sold thereafter and while every care will be taken to look after entries, items are entered at the owner's risk. Rosettes will be awarded to the best in categories and all entries will be entered into a lucky draw for a chance to win a prize.
